Youth Ministry Update

For the last couple of years I have attended the Toronto Children's Ministry Conference, both in person and online. An incredible learning experience, that has enriched my understanding of Children's Ministry, and helped inspire many of the lessons that I have shared with the children and families at Trinity. When I looked into attending a third year, I noticed that most of the speakers were the same as the previous years, with the exception of the keynote speaker, Dave Csinos PhD, author, professor and Founder & President of *Faith Forward*, an ecumenical organization for innovation in ministry with children, youth, and families. In seeking to expand my horizons further, I looked into where else I may learn from Dave Csinos and came across, the Symposium on the Spirituality of Children, where he was one of several guest speakers I hadn't yet learned from.



Due to the pandemic it was an online only offering by *Lifelong Learning at Virginia Theological Seminary*. The symposium explored the latest research in the spirituality of children. The keynote speaker was Jerome Berryman PhD, who founded *Godly Play*. Developed in 1974, *Godly Play* helps children experience God in a way that encourages children to develop their own relationship with God by being invited to wonder. Jerome's message, *Playing in the Flow of God's Creative Power: A Theology of Childhood*, spoke in depth about *Godly play* and how it can help children to develop their own theology.




Likewise, Dave Csinos whose message: *All, Some, None: A Multilayered Interpretation of Children's Theological Meaning-Making*, spoke about his research of children's understanding of God. By interviewing and observing children from many different churches of various denominations, Dave explored the ways those churches affected a child's ability to form their own unique theology. This notion that children be allowed from a very young age, to form their own relationship with God and their own unique understanding, is not new to the United Church. My observations, having experienced many churches throughout the years, is that this encouragement isn't always nourished. I believe that this type of encouragement is not only what Jesus calls us to do, but I believe that this relationship building and nourishment of children's spirituality is fundamental in helping churches remain relevant in times where life can take people in other directions.





There were several other speakers including a diverse panel of individuals well-experienced in Children’s Ministry. While learning in person has its own benefits, learning online can also be a rewarding experience. With almost 200 attendees from across the globe, the engaging experience has renewed my faith that children’s ministry remains hopeful and that children are capable gifts from God who need to be encouraged to build their own relationship and understanding of God, something I do my best to do here with the children.



As Sunday School in person has resumed, I look to continue teaching our children the importance of developing their own unique relationship with God and encourage them to wonder and create.

RECAP OF TRINITY GOLF LEAGUE - 2021

We had our best year ever for our Trinity Golf League, even though we lost a total of six days due to Covid 19 and 3 days to rain, including the final day of the golf season.

With every golfer donating \$5.00 per game, we were able to collect \$1,295. Each player will receive a tax receipt at the end of the year for each game played.

We were very fortunate to gain three new players on a regular basis as well as several others who played on a casual basis. The owners of the golf course were extremely happy to host our league. It is hoped that by next June, when things hopefully are back to normal, we can once again hold our annual golf tournament, which has always been one of our major fun(d) raisers.



Our league is open to anyone who is interested in playing, regardless of their ability. To make it a little easier for high handicap players, we have a 'double par pickup' rule, which means once you have taken twice the number of strokes that represent par for that particular hole, you pick up your ball and go to the next tee. Because the course has no driving range, we also allow a 'mulligan' on the first hole and on the 18th, which is a long par 5.

If you or any of your friends are interested in joining us, you are more than welcome and you do not have to commit to playing every Tuesday morning at 9:00 a.m. Let me know and I will gladly add your name to our e-mail list so we can let you know when the new season starts. All of our players are extremely friendly and you will have a chance to make many new acquaintances, many of whom are member of other churches in Oakville.


